Disclosure, Authorization and Deposit Agreement

Disclosure and Authorization: By signing below, Applicant declares that the information on this rental application is true and correct, and understands that false statements may result in rejection of this and any future applications submitted. In consideration of Applicant's request to lease housing through Iskalo Development Corp. ("Iskalo"), Applicant authorizes Iskalo to make such inquiries as are necessary to verify the information contained in this rental application. Applicant understands and agrees that Iskalo will rely upon the accuracy and completeness of the information contained in this rental application in its consideration to enter into a rental agreement or lease, and applicant represents and warrants the facts and information contained herein are complete, true and accurate. If any facts or information prove to be untrue or incomplete, Iskalo reserves the right to reject this application or, to the extent that a lease is signed prior to discovery of such untrue, inaccurate or incomplete information, terminate Applicant's tenancy and collect any damages incurred by Iskalo resulting therefrom, including reasonable attorneys' fees. Iskalo welcomes all applicants and supports fair housing. Iskalo does not refuse to lease or rent housing accommodations or property because of sex, marital status, race, creed, religion, age, familial status, physical or mental handicap, color or national origin.

Iskalo conducts applicant screening of persons applying to live in our managed properties. Such screenings may include criminal background investigations. Prior to acceptance of an applicant, Iskalo may use an independent consumer reporting agency to search public records which may contain criminal background information regarding the applicant. Iskalo will determine if the criminal background information pertains to the applicant and if the report indicates that one or more such felony and or misdemeanor records were found. Iskalo will then compare the records to our acceptance policies to determine whether or not the applicant may be accepted. If a rental application is declined based on the discovery of public records that indicate an unacceptable criminal background, the applicant will be given the name, address, and telephone number of the consumer reporting agency that provided the criminal background report. An applicant who is declined based on a criminal background may obtain a free copy of the report and may initiate a reinvestigation to have any erroneous information contained in the report corrected. The consumer reporting agency will advise the applicant of the procedures that should be followed in order to do so.

Deposit: This Disclosure, Authorization and Deposit Agreement forms a part of your Rental Application. A deposit equal to \$200.00 is due at the time you submit your Rental Application. If we approve your Rental Application and enter into a Lease Agreement, we will keep your deposit and apply it to a portion of your security deposit under the Lease Agreement. If (a) we do not approve your Rental Application, or (b) you notify us within 48 hours of our approving your Rental Application that you do not wish to sign a Lease Agreement, we will keep \$50 of your deposit as an application fee and return the balance to you. If you fail to notify us within this 48 hour period, we will retain the full deposit received and will release you from any further obligation to us. If, after reviewing your Rental Application, we inform you that we cannot approve it unless you provide a guarantor, you may withdraw your Rental Application and receive a refund of your deposit, less \$50, which we will keep as an application fee. If you agree to provide a guarantor, you must do so within three business days for our notice to you that a guarantor will be required, or you will forfeit your entire deposit.

Our acceptance of your deposit under this Deposit Agreement does not constitute our approval of your Application or an agreement to enter into a Lease Agreement with you.
